- 1) Call to Order and Agenda Review** – The May 10, 2023, Advisory Council meeting was called to order at 9:03 am by Vice-Chair Martha Shapiro.

- 2) **Pledge of Allegiance** – The Pledge of Allegiance was led by Maureen Hodge.
- 3) **Roll Call and Motion to Accept Online Virtual Attendance for Those Declaring “Emergency Circumstances”** – Rene Verduzco called roll. The Advisory Council reached a quorum with 18 of 30 members present. Dr. Gorbach attending via Zoom under the emergency circumstance exception. Smita Dandekar attended via Zoom as a member of the public due to not having an emergency circumstance. Rossanna Guerra joined the meeting in person after roll call and did not participate in any voting items.
- 4) **Administering the Oath of Office** – Monique Nowlin swore in Alvin Brown and Sue Huges to The Ventura County Area Agency on Aging Advisor Council.
- 5) **Approval of Area Agency on Aging Advisory Council Minutes of May 10, 2023.**

PRESENTATION/INFORMATIONAL ITEMS

- 8) **FY 2023-2024 State Budget Update** – Victoria Jump informed the council that the governor did not reduce the budget. The timeline for spending has been increased from 3 years to 5 years. The Older Adults Recovery and Resilience funds deadline has been extended from December 2023 to December 2024. VCAAA has received approximately 800 to 900 thousand in Nutrition Infrastructure Funds to replace outdated equipment for senior nutrition sites. VCAAA and Behavioral Health have received additional funding for older adults' mental health services. Lastly, Medi-Cal eligibility age range has been lowered to age 50 plus and includes undocumented immigrants to be eligible for IHSS.
- 9) **Agency Merger Update** – Only July 1, 2023, Area Agency on Aging has officially moved to The Human Services Agency establishing the Department of Aging and Disability Services. Currently, Area Agency on Aging and Public Authority are under the umbrella of the newly formed Department of Aging and Disability Services. Public Authority is the registry for all In Home Support Services providers. Public Authority also has an advisory body similar to the VCAAA Advisory Council. Victoria Jump clarified that VCAAA services will continue to operate at the 646 County Square Drive building, but a few staff members have relocated to the main Human Services Agency building located at 855 Partridge Drive. Victoria Jump and Monique Nowlin still have an office at the VCAAA building and will have a presence at both offices.
- 10) **Advisory Council Metrics for FY 2023-2024** – An online survey link was sent to Advisory Council members for demographic purposes. The intention in collecting this information is to improve council representation through the recruitment of new council members for vacant seats while expanding perspectives that reflect the full diversity of Ventura County.
- 11) **PIO Update** – Roger Horne informed the council that a new HSA/AAA logo has been approved yesterday July 11, 2023. Roger has created a Threads social media account for VCAAA. In May 2023, the website had over 14,000 page views which is the highest in 3 years. The Optimal Aging committee has began promoting nominations for the 2023 Legacy Awards.

- 12) **Cal Aim Update** – Cal Aim is an enhanced care management program that went into effect in January of 2023. The program is an expansion of Medi-Cal benefits providing case management and community supports. Currently, the Cal Aim team consists of 7 employees with a caseload of over 200 clients. In September of 2023, the Board of Supervisors will approve an additional 20 employees.
- 13) **Committee Selection** – Subcommittee selections for Advisory Council fiscal year 2023-2024 are due. Monique Nowlin reminded the council to turn in selections to Rene Verduzco.
- 14) **Other Committee Meetings:**
 - a. **California Senior Legislature Update** – Tony Gitt presented the CSL Legislative Summary Report and the CSL Newsletter “The Advocate”. Dr. Gorbach provided an update on her Ageism Awareness Week resolution. Initially, the resolution was denied but Dr. Gorbach has resubmitted the resolution this year. Karen has also submitted a request for a task force for the study of potential public policy related to the development, deployment and oversight of artificial intelligence in the field of healthcare specifically for vulnerable populations including older adults and people with disabilities.
 - b. **VCAAA Foundation Update** – Monique Nowlin updated the council on the VCAAA Foundation’s last meeting. James Schicker is the new chair for the VCAAA Foundation. The Foundation has approved additional funding for pet food for our FoodBox and Project Room Key programs. They have also approved the purchase of 2 sets of uniforms for our Senior Nutrition Farm staff. The Foundation is also recruiting new board members.
 - c. **LGBTQ Aging Coalition** – The last LGBTQ Aging Coalition meeting was held at the VCAAA Senior Nutrition Farm. The coalition attended 3 pride events in June. The next meeting for the LGBTQ Coalition will be tomorrow July, 13, 2023 via Zoom.
 - d. **Dementia Friendly Ventura County** – The Living Well Caring Well one-stop shops have been going for over a year now. The events have been such a success that the committee has decided to continue. The next Living Well Caring Well event will be held on September 6, 2023 at Camarillo Healthcare District from 10 am – 12pm. The next regular meeting of Dementia Friendly Ventura County will be on August 2, 2023 at 11 am via Zoom.

- 1. Welcome and Introductions** – The VCAAA Housing Committee meeting was called to order at 3:04 pm. The Housing Committee reached a quorum with 6 of 8 members present. Sue Hughes (District 3), attended her first VCAAA Housing Committee Meeting. Other committee members and staff introduced themselves to Sue.
- 2. Public Comments** – No public comments.
- 3. HomeShare Update** – Dr. Rhodes explained to Sue what Home Share does for the community. Ben went over the process of initial interest, screening, application, background check and then placement. On average, Home Share receives 40 applications per month. The program is split between 70% seekers and 30% providers which is consistent with the national average.

Monique Nowlin reviewed Home Share’s history. Initially the program was run by The City of Ventura before Supervisor Bennett approved funding for Ventura County Home Share. Monique explained that Home Share is 100% voluntary, we cannot force any participants to match or continue living together. VCAAA does offer some level of conflict resolution for participants.

Jerrica went over Home Share stats since the last Housing Committee Meeting on May 16, 2023. 77 Initial interest Forms have been received, 55 have

completed the full application, and Jerrica has been able to make 29 match referrals.
